The parties herein present the following agreement to the court or to the designee of the Chief of the Bureau of Collections of the Department of Human Services and request an exemption from immediate income withholding.

_____ is the support obligor herein and
_____ is the support obligee.

1. The parties understand that state and federal law provide for the payment of a support obligation through immediate income withholding.

2. The parties state their intent to enter an agreement which provides for an alternative arrangement and request that an exemption from immediate income withholding be granted.

3. The obligor agrees to submit payments in the amount specified in the order for support, to the location directed in the order for support, on the date due.

- The obligor agrees to automatic withdrawal of support payments from the obligor's bank account to further guarantee regular payment.
- The obligor does not agree to automatic withdrawal of support payments from the obligor's bank account.

WRITTEN AGREEMENT FOR PAYMENT OF CHILD SUPPORT (page 2)

The obligor understands that payments become delinquent on the date after the date due.

4. The obligor agrees to notify the Child Support Recovery Unit of changes in the obligor's address or employer and to provide information about employment-related health insurance coverage to which the obligor has access.

5. The parties understand that if support payments become assigned to the State due to the receipt of public assistance, the Department of Human Services is considered a party to the support order, and this written agreement is void.

6. The parties understand that even if this agreement is approved, immediate income withholding may be implemented if the obligor requests that withholding begin or the obligee or party to the proceeding requests that withholding begin, if the Child Support Recovery Unit approves the request and issues written notice to the obligor. In addition, regardless of the existence of a written agreement, if support payments become delinquent in an amount equal to the amount payable for one month, the Child Support Recovery Unit will enter an order for income withholding as provided by Iowa Code 252D.1. The existence of a one-month delinquency voids this written agreement.

7. The parties state that this agreement for an alternative agreement is being entered into voluntarily.
