DHS Appoints Workgroups for Mental Health Redesign

DES MOINES, **Iowa** – On Tuesday Department of Human Services Director Chuck Palmer announced selections for workgroups to recommend sweeping changes in the delivery of mental health services.

"I'm gratified that lowa's most skilled and resourceful experts volunteered their service for these groups, and I'm confident that the result of their work will help us build a mental health delivery system that will meet the needs of customers and taxpayers alike," Palmer said.

Legislation approved in the 2011 session directs the DHS to appoint and lead workgroups to recommend changes to a current system that has funding and service inequities.

Workgroups will recommend proposals to:

- Meet the needs of consumers for disability services in responsive and cost-effective manner.
- Develop a core set of services available for anyone who is eligible for governmentfunded mental health or disability services.
- Reorganize adult disability services into a system administered on a regional basis.
- Redesign publicly funded children's mental health and disability services.
- Identify approaches to address the needs for publicly funded services for persons with brain injury and review best practices.
- Implement services in accordance with Olmstead principles.
- Address co-occurring mental health, intellectual disability, brain injury, and substance

The groups must report their suggestions by mid December. Legislators, who declared their intent to redesign the current system, will consider the recommendations when they return in January.

The work is divided into several groups, including adult mental health, brain injury, children's disability, intellectual disability services, and regional services. Palmer said he will ask the work groups to convene by the middle of August.
