## CITATION AND WARNING

Pursuant to the provisions of Iowa Code Sections 17A.18, 147A.7, and Iowa Administrative Code (I.A.C.) 641—131.7, the Iowa Department of Public Health is proposing to issue a **Citation and Warning** to the individual identified above.

The department may cite and warn an emergency medical care provider when it finds that the certificate holder has committed any of the following acts or offenses:

Fraud in procuring certification or renewal including, but not limited to:
(2) False representations of a material fact, whether by word or by conduct, by false or misleading allegations, or by concealment of that which should have been disclosed when making application for a certification in this state.
IAC 641—131.7(2)d

Failure to comply with a subpoend issued by the department or failure to cooperate with an investigation of the department. IAC 641-131.7(2)h

Violating a statute of this state, another state, or the United States, without regard to its designation as either a felony or misdemeanor, which relates to the provision of emergency medical care, including but not limited to a crime involving dishonesty, fraud, theft, embezzlement, controlled substances, substance abuse, assault, sexual abuse, sexual misconduct, or homicide. A copy of the record of conviction or plea of guilty is conclusive evidence of the violation. Iowa Code Section 147A.7(1)j and IAC 641—131.7(2)t

Failure to respond within 30 days of receipt, unless otherwise specified, of communication from the department which was sent by registered or certified mail. IAC 641—131.7(2)ab

The following incidents resulted in issuance of this proposed action:

On September 28, 2009, when completing the Affirmative Renewal Application for your First Responder certification, you answered the question, have you been convicted of, found guilty of, or entered a plea of no contest to a felony or misdemeanor crime, in the affirmative. On November 23, 2009, you received a certified letter from the Department requesting that you submit the dates, locations, charges, court disposition and current status of the charges. If the charge involved alcohol, you were to include any court ordered substance abuse evaluation.

The letter advised you that failure to reply within 30 days could result in disciplinary action, including revocation. You failed to provide the requested information in the time frame specified. In addition, you received a deferred conviction of operating while intoxicated on September 15, 2009. Complete information was received on January 28. 2010.

You are hereby **CITED** for failing to respond to the Department's request for information, and violating a statute of the state of Iowa. You are **WARNED** that failing to respond to a request of the Department, or violating a statute of the state of Iowa in the future may result in further disciplinary action, including suspension or revocation of your EMS certification.

You have the right to request a hearing concerning this notice of disciplinary action. A request for a hearing must be submitted in writing to the Department by certified mail, return receipt requested, within twenty (20) days of receipt of this Notice of Proposed Action. The written request must be submitted to the Iowa Department of Public Health. Bureau of Emergency Medical Services, Lucas State Office Building, 321 E 12<sup>th</sup> St, Des Moines, Iowa 50319. If the request is made within the twenty (20) day time limit, the proposed action is suspended pending the outcome of the hearing. Prior to or at the hearing, the Department may rescind the notice upon satisfaction that the reason for the action has been or will be removed.

If no request for a hearing is received within the twenty (20) day time period, the disciplinary action proposed herein shall become effective and shall be final agency action.
