Dear Child Care Provider,

This letter is in regards to the 2-10-2014 compliance check of your Level B, Registered Child Development Home. Iowa Code Chapter 237A and 441 Iowa Administrative Code, Chapter 110, describes specific requirements that must be met by a Registered Child Development Home. The following areas were out of compliance at the time of my visit:

- 110.5(1)k Fire and tornado drills are practiced monthly and documentation kept.-Michelle states she will start documenting.
- 110.5(2)c An individual file is maintained for each staff assistant and contains:
- 110.5(2)c A completed DHS Criminal History Record Check, form B, 595-1396-enclosed
- 110.5(2)c A completed Request for Child Abuse Information, form 470-0643-enclosed
- 110.5(8) Children's Files
- 110.5(8)c A signed medical consent from the parent authorizing emergency treatment. Michelle has, but need to be updated
- 110.5(8)e For infants and preschoolers: A statement of health signed by a physician submitted annually. Michelle has, but needs to be updated.
- 110.5(8)e For school aged children: An annual statement of health condition signed by the parent or legal guardian, annually from date of admission physical. Michelle has but needs to be updated.

Non-compliance with any of the mandated regulatory requirements listed above may lead to the cancellation or revocation of your Child Development Home Registration. **Please take whatever steps are necessary to completely address each of the violations noted above. It is essential you correct all above-mentioned violations within the next 45 days.**

Based on the items out of compliance listed above, you will be required to have a recheck or follow up visit to your home. This visit will occur after the 45 day time period has elapsed.

**I certify that I have taken all of the steps necessary to correct each of the identified violations noted above and am now in complete compliance with all of the Departmental mandated regulatory rules.**
