Dear Child Care Provider,

This letter is in regards to the 3-19-2014 compliance check of your Level B, Registered Child Development Home. Iowa Code Chapter 237A and 441 Iowa Administrative Code, Chapter 110, describes specific requirements that must be met by a Registered Child Development Home. The following areas were out of compliance at the time of my visit:

- 110.5(1)f Combustible materials are kept away from furnaces, stoves, gas dryers, or water heaters. (needs to move some items away from the furnace)
- 110.5(1)g Safety barriers are at stairways and doors as needed. (have a half door they will put back on)
- 110.5(1)k Fire and tornado drills are practiced monthly and documentation kept. (not documented every month)
- 110.5(1)q All dogs and cats have annual examinations. Records of the exams are on file and must verify that routine immunizations are current and animal is free of endo and ecto parasites. (3/28/14 appointment)
- 110.5(1)v The provider has written policies about responding to health-related emergencies.
- 110.5(2) A provider file is maintained and contains:
  - 110.5(2)a A physician's signed statement of health and immunization status on the provider and all members of the household who may be present when children are in the home. Statements must be obtained at the time of initial registration and updated every two years. (needs for all family members)

Andrew has not yet been approved as an assistant or substitute, so you are not yet required to have a file on him at this time. He should not be providing care independently, until he is approved as a substitute.

- 110.5(8) Children's Files
  - 110.5(8)d For infants and preschoolers: An admission physical examination, on the first day of attendance, including past health history, status of present health, allergies and restrictive

conditions, and recommendations for continued care when necessary. The date of the exam is not more than 12 months before the child's first day of attendance.

110.5(8)d For school-aged children: On the first day of attendance, a statement of health status signed by the parent or legal guardian.

110.5(8)g A signed and dated immunization certificate provided by the state department of public health.

110.5(8)h For each school-age child, record of a physical exam completed at the time of school enrollment or since.

(physicals-Payton and Paige)  
(physicals and Immunizations-Ally and Broody)

Non-compliance with any of the mandated regulatory requirements listed above may lead to the cancellation or revocation of your Child Development Home Registration. **Please take whatever steps are necessary to completely address each of the violations noted above. It is essential you correct all above-mentioned violations within the next 45 days.**

Based on the items out of compliance listed above, you will be required to have a recheck or follow up visit to your home. This visit will occur after the 45 day time period has elapsed.

Please check mark each of the boxes listed above when the necessary corrections have been completed. By doing so, you certify that you have completed all of the mandated regulatory requirements contained within each identified section.

I certify that I have taken all of the steps necessary to correct each of the identified violations noted above and am now in complete compliance with all of the Departmental mandated regulatory rules.
