Dear Child Care Provider,

This letter is in regards to the 7-24-14 compliance check of your Level B, Registered Child Development Home. Iowa Code Chapter 237A and 441 Iowa Administrative Code, Chapter 110, describes specific requirements that must be met by a Registered Child Development Home. The following areas were out of compliance at the time of my visit:

- 110.4 No more children are in care than the rules for the specific category will allow.
- 110.5(1)e Electrical wiring shall be maintained. (TV in basement)
- 110.5(1)j Emergency and disaster plans for fire and tornado are written and posted by primary and secondary exits. (basement)
- 110.5(1)j The plans shall clearly map building evacuation routes in case of fire, a safe place indoors in case of tornado, and flood shelter areas. (basement exit)
- 110.5(2) A provider file is maintained and contains:
 - 110.5(2)a A physician's signed statement of health and immunization status on the provider and all members of the household who may be present when children are in the home. Statements must be obtained at the time of initial registration and updated every two years. (Jillian and Autumn need)
 - 110.5(8)a Identifying information including, at a minimum, the child's name, birth date, parent's name, address, telephone number, special needs of the child and the parent's work address and telephone number.
 - 110.5(8)e For infants and preschoolers: A statement of health signed by a physician submitted annually.
 - 110.5(8)e For school aged children: An annual statement of health condition signed by the parent or legal guardian, annually from date of admission physical. (I I)
 - 110.9(1)f When more than 8 children are present for more than two hours, a DHS-approved assistant at least 14 years old is present. (need assistance approved)

Non-compliance with any of the mandated regulatory requirements listed above may lead to the cancellation or revocation of your Child Development Home Registration. **Please take whatever steps are necessary to completely address each of the violations noted above. It is essential you correct all above-mentioned violations within the next 45 days.**

Contact CCR&R if you need assistance getting your assistant approved.

Based on the items out of compliance listed above, you will be required to have a recheck or follow up visit to your home. This visit will occur after the 45 day time period has elapsed.
