


Q1 At which level do you describe your partnerships?





Q3 Private and public agency workers clearly communicate the desired family outcomes and how they collectively plan with the family to reach those outcomes.



Q4 Private and public agency workers invite participation of appropriate family and community supports to assist families in reaching safe case closure.









Q8 Public and private agency workers consistently put forth effort to improve their work with children, youth, and families in order to reach better outcomes.


