Dear Child Care Provider,

This letter is in regards to the February 25, 2014 compliance check of your Level B, Registered Child Development Home. Iowa Code Chapter 237A and 441 Iowa Administrative Code, Chapter 110, describes specific requirements that must be met by a Registered Child Development Home. The following areas were out of compliance at the time of my visit:

- 110.5(2)b Two hours of approved child abuse and neglect mandatory reporter training (and every 5 years thereafter).- ( Please provide, says she took back in 3/2013).
- 110.5(2)b Certification by an approved trainer/organization in infant and child first-aid that includes mouth-to-mouth resuscitation. Certification will be maintained throughout period of registration. If they are unable to locate first aid training that includes mouth-to-mouth resuscitation, they must complete both a first aid course and CPR.
- 110.5(8)d For school-aged children: On the first day of attendance, a statement of health status signed by the parent or legal guardian. ( Please obtain for one).
- 110.5(8)g A signed and dated immunization certificate provided by the state department of public health. ( Need for two).
- 110.5(8)h For each school-age child, record of a physical exam completed at the time of school enrollment or since. ( Need for two- will be including physical forms with this letter).

Non-compliance with any of the mandated regulatory requirements listed above may lead to the cancellation or revocation of your Child Development Home Registration. **Please take whatever steps are necessary to completely address each of the violations noted above. It is essential you correct all above-mentioned violations within the next 45 days.**

Based on the items out of compliance listed above, you will be required to have a recheck or follow up visit to your home. This visit will occur after the 45 day time period has elapsed. Child Care Resource and Referral will check your home for completion of your items out of compliance with the checklist. They can be reached at 319-233-0804
