Dear Child Care Provider,

This letter is in regards to the 3-25-2014 compliance check of your Level B, Registered Child Development Home. Iowa Code Chapter 237A and 441 Iowa Administrative Code, Chapter 110, describes specific requirements that must be met by a Registered Child Development Home. The following areas were out of compliance at the time of my visit:

- 110.5(1)e All accessible electrical outlets are safely capped. (missing a couple)
- 110.5(2) A provider file is maintained and contains:
 - 110.5(2)b Two hours of approved child abuse and neglect mandatory reporter training (and every 5 years thereafter.) (Expired-needs to retake)
 - 110.5(2)c An individual file is maintained for each staff assistant and contains:
 - 110.5(2)c A completed DHS Criminal History Record Check, form B, 595-1396 (needs to have mailed to her)
 - 110.5(2)c A completed Request for Child Abuse Information, form 470-0643 (needs to have mailed to her)
 - 110.5(2)c Certification of two hours of approved training relating to identification and reporting of child abuse within 6 months of employment and repeated every 5 years. (just expired 2-9-14- needs to retake)
 - 110.5(2)d An individual file is maintained for each substitute and contains: (same as above)
 - 110.5(2)d A completed DHS Criminal History Record Check, form B, 595-1396.
 - 110.5(2)d A completed Request for Child Abuse Information, form 470-0643
 - 110.5(2)d Certification of two hours of approved training relating to identification and reporting of child abuse within 6 months of employment and repeated every 5 years. DUE 2-9-2014
- 110.5(8) Children's Files

110.5(8)c A signed medical consent from the parent authorizing emergency treatment. (Adrian, Autumn, Laynie, Isaac, Aviana, Alex)

Non-compliance with any of the mandated regulatory requirements listed above may lead to the cancellation or revocation of your Child Development Home Registration. **Please take whatever steps are necessary to completely address each of the violations noted above. It is essential you correct all above-mentioned violations within the next 45 days.**

Based on the items out of compliance listed above, you will be required to have a recheck or follow up visit to your home. This visit will occur after the 45 day time period has elapsed.

Please check mark each of the boxes listed above when the necessary corrections have been completed. By doing so, you certify that you have completed all of the mandated regulatory requirements contained within each identified section.


