Dear Child Care Provider,

This letter is in regards to the 11-14-2014 compliance check of your Level A, Registered Child Development Home. Iowa Code Chapter 237A and 441 Iowa Administrative Code, Chapter 110, describes specific requirements that must be met by a Registered Child Development Home. The following areas were out of compliance at the time of my visit:

- 110.5(1)f Combustible materials are kept away from furnaces, stoves, gas dryers, or water heaters. (plastic chairs, outdoor toys need moved)
- 110.5(1)h Is fenced off when located on a busy thoroughfare or near a hazard. (play in backyard, not by Highway, 100% supervision)
- 110.5(8) Children's Files (Aiden, Kaylee, John)
- 110.5(8) An individual file is maintained for each child and updated annually or when there are changes. Each file contains:
  - 110.5(8)a Identifying information including, at a minimum, the child's name, birth date, parent's name, address, telephone number, special needs of the child and the parent's work address and telephone number.
  - 110.5(8)b Emergency information including where the parent can be reached, the name, street address, city and telephone of the child's regular doctor, and the name number, telephone number, and relationship to the child of another adult available in case of emergency.
  - 110.5(8)c A signed medical consent from the parent authorizing emergency treatment.
  - 110.5(8)d For infants and preschoolers: An admission physical examination, on the first day of attendance, including past health history, status of present health, allergies and restrictive conditions, and recommendations for continued care when necessary. The date of the exam is not more than 12 months before the child's first day of attendance. (Brody, Kohen, Aidyn)
  - 110.5(8)d For school-aged children: On the first day of attendance, a statement of health status signed by the parent or legal guardian.

110.5(8)e For school aged children: An annual statement of health condition signed by the parent or legal guardian, annually from date of admission physical.

110.5(8)f A list signed by the parent which names persons authorized to pick up the child, their telephone number, and relationship to the child. (Aiden, Kaylee, John)

110.5(8)g A signed and dated immunization certificate provided by the state department of public health. . (Aiden, Kaylee, John, Kohen, Aidyn)

Non-compliance with any of the mandated regulatory requirements listed above may lead to the cancellation or revocation of your Child Development Home Registration. **Please take whatever steps are necessary to completely address each of the violations noted above. It is essential you correct all above-mentioned violations within the next 45 days.**

Based on the items out of compliance listed above, you will be required to have a recheck or follow up visit to your home. This visit will occur after the 45 day time period has elapsed.

**Please check mark each of the boxes listed above when the necessary corrections have been completed. By doing so, you certify that you have completed all of the mandated regulatory requirements contained within each identified section.**


