ACO Partner Update

The Partner Update is a monthly communications effort designed to share pertinent and important information that is specific to Iowa Medicaid's Accountable Care Organizations.

April 2015

Dashboard Refreshed April 29, 2015: The Dashboard tool reflects claims paid through January 31, 2015.

Current Statistics:

- Iowa Medicaid has five ACO agreements for the wellness population which include: Broadlawns Medical Center, Iowa Health+, Mercy ACO, UnityPoint Health Partners, and the University of Iowa Health Alliance.
- Mercy ACO was welcomed April 1, 2015.
- There were 887 individual Primary Care Providers (PCPs) analyzed for their Value Index Score (VIS) this month.
- There are 800 PCPs with a VIS Target for 2015.
- There are a total of 600,505 Medicaid members analyzed in the dashboard which include percentages of the following:
 - Health and Non Users (68.11%)
 - Pregnancy/Delivery (1.52%)
 - Significant Acute (8.07%)
 - Minor Chronic (6.76%)
 - Moderate Chronic (8.91%)
 - Dominant Chronic (6.17%)
 - Malignancies and Catastrophic (.45%)

2014 2nd Quarter's VIS Incentive Payment: The second quarter VIS incentive payment was paid April 10, 2015. For this quarter, a total of \$124,074 was paid to Patient Managers and ACOs. The IME compiled and sent each ACO a report of Patient Managers and VIS bonus totals on April 6, 2014. The third quarter 2014 VIS payment is expected in mid-May.

Guiding Principle

The Iowa Medicaid Enterprise (IME) is responsible for supporting the healthcare delivery system's ability to analyze data, improve care, and track program measures by sharing reliable and consistent information in a timely way. The healthcare delivery system is responsible for analyzing and taking action on data by maximizing resources and implementing improved processes. Both the IME and the healthcare delivery system are ultimately responsible for improving population health and the delivery of healthcare as well as lowering the total cost of care (triple aim).

2014 Exam Bonus: The 2014 exam incentive payment has been calculated. This annual payment goes to Patient Managers or the ACO of Patient Managers who have assisted at least fifty percent of their assigned members in getting a comprehensive exam. The measure only looks at members assigned to the Patient Manager for at least six months. However, the IME has also included members with less than six months assignment if that member received an exam. The method was also used to calculate the ACO Healthy Behaviors measure, and to ensure that members recently assigned are prioritized similarly to members already assigned. For Patient Managers with at least a fifty percent completion rate, a \$10 per exam per year bonus will be paid for those members they assisted in completing an exam. The results are listed below and compile the amount earned by each Patient Manager by each ACO.

The completion rate calculated at the ACO level:

- Broadlawns = 25%
- Iowa Health+ = 28%
- UnityPoint = 31%
- UIHA = 37%
- Non ACO Patient Managers = 27%

Monthly Claims Sharing Process: The process to share claims with ACO providers on a monthly basis kicked off in October. Once your ACO has successfully accepted a test file, notify 3M to receive the three year file. From that point, regular claim updates will be sent
