



## 2016 | Last Chance To Enroll in the Medicaid EHR Incentive Program

Program Year 2016 is the final year in which eligible professionals (EP)—which includes Dentists—can begin to participate in the Medicaid Electronic Health Record (EHR) Incentive Program. There are many benefits to program participation, including the following:

- Providers that are eligible to participate can receive up to \$63,750 for full participation in the program. This includes a payment in the first participation year of \$21,250 to adopt, implement, or upgrade (AIU) to a Certified Electronic Health Record Technology (CEHRT) system.
- The opportunity to receive FREE Meaningful Use assistance through IME's partner Telligen who can assist with:
  - Tools, resources and technical assistance
- Achieve measurable improvements in patient health care delivery and performance to promote better patient outcomes through the use of CEHRT:
  - Diagnostics and patient safety
  - Practice efficiencies and cost savings, including documentation and coding
  - Care coordination, including electronic exchange of clinical information with other designated providers
  - Patient participation/self-management

### AM I ELIGIBLE?

To participate in the Medicaid EHR Incentive Program, an eligible professional must:

- Be actively enrolled as an Iowa Medicaid provider
- Have adopted, implemented or upgraded to 2014 Certified EHR Technology
- Meet a minimum Medicaid Patient Volume threshold of 30 percent.
  - For the 2016 incentive year, an EP will use any continuous 90-day period in 2015 to complete the following calculation:
    - Denominator: What is the TOTAL number of patient encounters within the selected 90-day period?
    - Numerator: What is the TOTAL number of Medicaid encounters (which can include Delta Dental Wellness Plan) for the selected 90-day period?
    - Is the calculation equal to, or greater than 30 percent.
