## Introduction

Iowa Code 29C.20A(5) requires the Iowa Department of Humans Services (DHS) to report annually by January 1 of each year, to the Legislative Fiscal Committee and the Government Oversight Committee concerning the activities of the Iowa Individual Assistance Grant Program (IIAGP) for the previous fiscal year.

## **State Fiscal Year 2017**

Beginning in July 2016, Iowa began to experience severe storm systems which created straightline winds, heavy rains, large hail, and flooding resulting in significant damage to private/personal property across some Iowa counties. Governor Branstad proclaimed the following disaster emergencies.
